20 TO ALL PARTIES AND/OR THEIR COUNSEL OF RECORD:

21 The anti-SLAPP motion by Respondent Aitana Vargas to strike the petition for a civil  
22 harassment restraining order came on for regular hearing at the above-noted date, time, and place.

1 Michael Creamer appeared for Respondent Aitana Vargas and Veronica Barton, Esq., of the Law Office  
2 of Veronica Barton appeared for Petitioner Hadari Oshri.

3 After the Court granted an opportunity for oral argument, the Court ruled as follows:

4 1. The Special Motion to Strike by Aitana Vargas pursuant to CCP §425.16 was granted.

5 The Petition was, at least in part, based upon acts Respondent Aitana Vargas taken in the  
6 constitutionally protected exercise her freedom of speech and freedom of the press. Thus, the burden  
7 shifted to Petitioner Hadari Oshri to establish a probability that she would prevail on her claims against  
8 Aitana Vargas. The Court found that Respondent Aitana Vargas was the prevailing party as Petitioner  
9 Hadari Oshri had failed to sustain her burden. As the prevailing party, Respondent Aitana Vargas may  
10 seek an award of attorneys fees pursuant to CCP §425.16.

11 2. By striking the Petition of Hadari Oshri, the temporary restraining order was dissolved.

12 3. Counsel for Aitana Vargas was ordered to prepare a notice of ruling.
